However, during the year under review one equity share held by Mr. Arabinda Roy as nominee of M/s Indian Farmers Fertiliser Cooperative Limited was transferred to Mr. Tomgee Kallingal as nominee of M/s Indian Farmers Fertiliser Cooperative Limited;
- 9. there was no transaction necessitating the Company to keep in abeyance rights to dividend, rights shares and bonus shares pending registration of transfer of shares;
- the Company during the year under review did not declared /paid any dividend and was not required to transfer any amounts of unpaid/unclaimed dividend/other amount as applicable to the Investor Education and Protection Fund in accordance with Section 125 of the Act;
- 11. the signing of Audited Financial Statement is as per the provisions of Section 134 of the Act and report of Directors is as per sub Sections (3), (4) and (5) thereof;
- 12. the Board of Directors of the Company was duly constituted. During the financial year ended 31.03.2021, Shri Ravindra Telang ceased as Director of the Company effective from September 7, 2020 and Shri Arun Kumar Yadav was appointed as an Additional Director of the Company with effect from the said date i.e., September 7, 2020 and was regularized as Director in the Annual General Meeting held on September 29, 2020 (hereinafter referred to as "AGM"). Also, Mr. Durga Pada Patra retired by rotation and was reappointed as Director at the said AGM. Further, Mr. Manish Gupta was designated as Managing Director of the Company with effect from July 7, 2020. The proper disclosures as required under the Act were made by the directors during the year under review. Further, Shri Bikash Chandra Raut and Shri Bhanu Sharma continued as the Chief Financial Officer and Company Secretary of the Company respectively and were paid remuneration during the year under review. However, post closure of financial the year under review Mr. Bhanu Sharma has resigned as Company Secretary of the Company and Mr. Akash Jain has been appointed as its Company Secretary.
- the continuation appointment / re-appointment / filling up of casual vacancies of auditors wherever applicable is as per the provisions of section 139 of the Act. M/s MSN & Associates, Chartered Accountants (Firm Registration No 006614C) who were appointed as Statutory Auditors of the Company for a period of five years at the 1st Annual General Meeting held on October 23, 2019 continued to be the statutory auditors of the Company during the year under review;
- 14. the Company was not required to take any approvals of the Central Government, National Company Law Tribunal, Regional Director, Registrar, Court or such other authorities under the various provisions of the Act during the year under review;
- the Company has not invited/accepted/renewed/repaid any deposit falling within the purview of Section 2(31), 73 and 74 read with Companies (Acceptance of Deposits) Rules, 2014;
- the Company has not made any borrowings from its directors, members, public financial institutions, banks & others and no charge was created, modified or satisfied in this respect during the financial year under review. However, the Company has obtained disbursement of previously approved term loan during the year under review;
